NOTIFICATION OF DROUGHT

Upon the declaration of drought by the State Government vide G.O.No. 180-Pr. Secy/Fish/DM dated 17.08.2010 of the Principal Secretary to the Government of West Bengal, Dept. of Disaster Management in the district of Purulia I, Avanindra Singh, IAS, District Magistrate and Collector of Purulia hereby notify that **all the mouzas included in the district of Purulia as affected by drought.**

I have satisfied myself through reports of the Dy. Director Agriculture (Administration) submitted on 15.08.2010 regarding deficit rainfall and sown area of Kharif crop (paddy in Purulia), that all the conditions, necessary for declaration of drought exist manifestly in all Mouzas of the Purulia district.

The notification shall be effective from today till the date it is revoked by me or the date the State Government revokes the drought through a specific order. Upon the issue of such an order revoking the declaration of drought, this notification shall stand cancelled/revoked on its own.


It is directed that all the concerned Departments at the district level commence relief programmes immediately upon the declaration of the notification and submit the progress of their schemes to the District Administration through various returns as to be prescribed in due course. It is also directed that information upon all the relief schemes be made available to the people of the district through the Government Website, local newspapers and other channels of mass media.
