Tender Notice For Storing Agent

Sealed Tenders are invited from all the intending bonafide and reputed persons to act as "Storing Agent" for storing of Food stuff (Rice, Musur Dal etc.) for supplementary Nutrition Programme of Santuri I.C.D.S. Project.

The Tender should be submitted in a sealed envelop superscribed "TENDER FOR STORING AGENT" on the top of the envelope.

TERMS AND CONDITIONS FOR SUBMITTING TENDERS FOR STORING AGENT

01. The period of tender will be valid from One year after date of approval .
02. The Storing Agent should have valid ownership of the proposed Godown. Name of the Storing Agent and details of godown should be furnished.
03. The location of godown must be within the periphery of Santuri P.S. and nearest to Godown will be given preference.
04. Godown should be pucca construction and concrete floor. Xerox copy of the approved site plan must be submitted alongwith the Tender.
05. Plinth area should be adequate to store minimum 3(Three) months stock requirement i.e. Rice 350 quintals, Musur Dal 125 quintals (approx - 800 sq.ft. space building).
06. Godown should be clean and well ventilated. It should also be protected from rats and insects.
07. The Godown is to be accessable to heavy trucks and it should be situated on Road side.
08. Stacking should be made as per F.C.I. Rules.
09. Adequate dunnage should be provided to Project the food commodities from dampness (Wooden dunnage is preferable) and the storing agent will be responsible for any shortage and damage of the food stuff.
10. Storing Agent will have to reconstitute the bags of Rice and Musur Dal if needed.
11. The Storing Agent will have to maintain Book records of food stuff, high lighting the "Entry and Exit" which will always be available for inspection by C.D.P.O. or his authorised representatives.
12. Successful Tenderer will have to deposit Rs 50,000/- (Rupees Fifty thousand) only as Security Deposit by way of N.S.C. (National Savings Certificate)/ Bank Draft duly pledged in favour of Child Development Project Officer, Santuri at the time of execution of contract deed.
13. Accepted Storing Agent should execute a contract deed in a Non-Judicial stamp paper of Rs 50/-.
14. If the accepted tenderer fails to execute deed of agreement and act as Storing Agent within the fixed date. The earnest money will be forfeited in favour of the Government.

15. Tender will not be entertained if there is any over written absence of valid and current Income Tax, VAT Registration Certificate, Credential in Original and earnest money of ₹10,000/- (Ten thousand Rupees) only in favour of C.D.P.O. Santuri in the form of N.S.C./ Bank Draft in a sealed envelope.
16. 26% Income Tax will be deducted from the bill at source as per Government Rules.
17. Date of submitting Tender is 22.11.2011 to upto 3 p.m. and it will be opened on 22.11.2011 at 3.30 p.m. at the Office of the Sub-Divisional Officer, Raghunathpur. No postal tender will be accepted.
18. Tender Committee reserve the right to reject or accept any Tender without assigning any reason whatsoever as and when required.
